### 2. PRICE CHANGES FOR THE 2023-2024 SMART AND SKILLED CONTRACT PERIOD

Training Services NSW regularly reviews and updates qualification prices and fees. Qualification price changes are being introduced and will take effect for training that commences on or after 1 July 2023.

# a. Indexation added to qualification prices for 2023-2024 but student fees will not be affected.

An increase (indexation) of 3.5 per cent has been applied to all qualification prices. The indexation increase will apply to enrolments that commence on or after 1 July 2023 (*Smart and Skilled Price and Fees Schedule* version 14.0).

Qualification price increases will be rounded to the nearest \$10 price point. Qualifications priced at \$4,000 or less will be increased by 3.5% and rounded up to the nearest \$10 price point.

Indexation adjustment will also apply to the pricing of part-qualifications.

## b. Regular review of prices for superseding qualifications

Since the last review, eighty-nine superseding qualifications have been added to the NSW Skills List. These qualifications were reviewed on their merits under the IPART pricing methodology.

The Department has found that eighty-five qualifications require no change in price when priced on their own merits.

Price changes will apply to four qualifications. These price changes will take effect for enrolments that commence on or after 1 July 2023. Student fees for these qualifications will not change.

The price of three qualifications will increase (see **Table 6** below).

### c. Price corrections

Prices of eleven qualifications have been corrected due to a system error (see **Table 8** below). Before indexation is applied, nine qualifications will have price increases and two will have a small price decrease. With indexation, all eleven qualifications have a net price increase.

These price changes will take effect for enrolments that commence on or after 1 July 2023. Student fees for these qualifications will not change.

No existing students will be affected by these changes.

# 3. REMOVAL OF THE CAP ON NEEDS BASED LOADING

Providers are currently paid a maximum of one needs-based loading and one location-based loading per enrolment.

For commencements from 1 July 2023, all applicable needs-based loadings will be payable (i.e. all needs-based loadings that the student meets the eligibility criteria).

This change means providers will be better resourced to provide additional supports, especially for students experiencing multiple forms of disadvantage. Students that receive additional supports are more likely to successfully complete their training.

The 'Disadvantaged Students' section of the 2023-24 Operating Guidelines will be updated with additional guidance regarding the provision of additional supports and how this relates to loading payments.

Providers should refer to the Smart and Skilled Contract and Operating Guidelines for 2023-24 for full details about loadings.

The closing date of the application has been extended to 5:00pm Wednesday 7 June 2023.

The NSW Skills List Additions Application is an opportunity for external stakeholders to propose qualifications to be added to the NSW Skills List for delivery under Smart and Skilled.

## 5. 2023-24 SMART AND SKILLED CONTRACT OFFERS

The Department has now issued Smart and Skilled Contract Offers and Review Notices for the 2023-24 Activity Period associated with the Smart and Skilled provider application held in late 2022. Most providers received an email notification directing them to their Contract Offer/Review Notice.

Alternatively, some providers will receive a Contract Offer/Review Notice via email from the Smart and Skilled Application email account.

Providers must accept or decline as instructed **by the date shown on their Contract Offer/Review Notice**.

# 6. CHANGES TO SMART AND SKILLED CONTRACT TERMS AND CONDITIONS, OPERATING GUIDELINES AND RELATED POLICIES FOR THE 2023-24 ACTIVITY PERIOD

There are several changes to the *Smart and Skilled Contract Terms and Conditions*, *Smart and Skilled Operating Guidelines* and some related policies for the 2023-24 Activity Period.

### a. Review of Smart and Skilled Policies 2023-2024

Training Services NSW has reviewed the policy documents that will apply for the 2023-24 Activity Period. Some settings are coming to an end on 30 June 2023 and Training Services NSW is reducing the number of standalone policy documents.

Updated versions of the following policy documents have been released:

- Smart and Skilled Fee Administration Policy (version 3.0)
- School Based Apprenticeship and Traineeship (SBAT) Fee Administration Policy (version 3.0)
- Smart and Skilled Student Eligibility Policy (version 2.0)
- School Based Apprenticeship and Traineeship (SBAT) Student Eligibility Policy (version 2.0)
- Smart and Skilled Skills Delivery and Management Policy (previously the Smart and Skilled Market Management Policy (Part A)
- Smart and Skilled Provider Access Policy (previously the Smart and Skilled Market Management Policy (Part B))
- Smart and Skilled Third-Party Brokering Arrangement Policy.

The updated policies are now available on the Smart and Skilled website and or STS Online.

These policies take effect from the date that a provider accepts a Smart and Skilled contract offer for 2023-24.

i. Summary of changes to the School Based Apprenticeship and Traineeship (SBAT) Fee Administration Policy (version 3.0) and School Based Apprenticeship and Traineeship (SBAT) Student Eligibility Policy (version 2.0).

These policies have been reviewed and updated to ensure language throughout is aligned to the respective Smart and Skilled policies, including the clarifications to evidence requirements.

#### b. New Policies

The Smart and Skilled Targeted Priorities Prevocational and Part Qualifications Policy has been developed for 2023-2024 and is available on the Smart and Skilled website. Associated Smart and Skilled Targeted Priorities Prevocational and Part Qualifications Operating Guidelines are also available on STS Online.

### c. Policy settings coming to an end on 30 June 2023.

Skilling for Recovery and the North Coast Recovery Fund Fee Waivers will end on 30 June 2023.

**Note:** Sections of the *Smart and Skilled Fee Administration Policy* version 2.8 will remain in effect until 30 June 2023 so far as it is necessary to enable commencements under Skilling for Recovery and the North Coast Recovery Fund Fee Waivers.

i. Retiring standalone policy documents - Skilling for Recovery Policy and Fee Free Apprenticeships and Fee Free Traineeships Policies

The Skilling for Recovery Policy will be retired as commencements under the program end on 30 June 2023.

The Fee Free Apprenticeships and Fee Free Traineeships Policies will also be retired on 30 June 2023 as these duplicate information in the Fee Administration Policy.

### 7. 2023-2024 FINANCIAL CAPS

The process of setting Financial Caps is underpinned by the *Smart and Skilled Skills Delivery and Management Policy* (formerly the Market Management Policy Part A). The policy outlines the provider's responsibilities and the Department's approach to managing the supply of subsidised training and Financial Caps for the 2023-24 Activity Period.

The pandemic saw a higher degree of uncertainty about training demand and provider cap performance. The Department took a more flexible approach to training sector management and utilisation of Financial Caps during this time. As the economy and training sector has stabilised following the pandemic, student participation and the ability to participate in training has normalised. The Department has set a new allocation and will be returning to a regular approach (pre-pandemic) to monitoring Financial Cap utilisation and managing the overall allocation of Financial Caps.
