- IRCs are made up of people with experience, skills and knowledge of their industry sector and may be individuals or representatives of businesses or organisations.
- IRCs operate as committees of the Australian Industry and Skills Committee (AISC) and the AISC is responsible for membership of the IRCs.

#### Responsibilities include:

- Directing their allocated Skills Service Organisation (SSO) in developing Cases for Change to request the commissioning of training package development work to meet the skills needs of industry.
- Gathering industry intelligence to inform training product development.
- Overseeing the development and review of training packages, including preparation of cases for endorsement and providing sign-off prior to submission to the AISC for endorsement.

## **Enrolled Nursing Project Overview**

This project will update the Enrolled Nursing Training Package Products in response to the *Key Drivers for Change* findings in the 2019 Industry Skills Forecast.

The review relates to the qualifications, skill set and Units of Competency contained in the HLT Training Package under the remit of the Enrolled Nursing IRC.

Industry has indicated that there are key skills shortfalls in relation to some specialist areas of enrolled nursing practice relating to paediatric nursing and gerontology nursing, as well as gaps in the elements of knowledge and skill relating to the administration of medication. These skills gaps, identified in the most recent review of the Training Package Products, have come about in part as a result of changes in health care delivery models and societal factors, such as the ageing population

## Key Changes in Draft 2 Units

### **All units:**

- Have had the Assessment Conditions revised to reduce confusion and clarify ANMAC requirements for providers.
- Filler word e.g. 'appropriate', 'recognise', 'interpret' etc. have been removed where possible.

### Units Removed:

- HLTENN044 (HLTENN010) Apply a palliative approach in nursing practice Note: Replacement HLTENN068 Provide end-of-life care and a palliative approach in nursing practice
- HLTENN039 (HLTENN005) Contribute to nursing care of a person with complex needs" Note: Content has been merged into
  - HLTENN043 Implement and monitor care for a person with acute health problems
  - HLTENN044 Implement and monitor care for a person with chronic health problems

## Key Changes in Draft 2 Units

### Units with significant change :

- HLTENN035 Practise nursing within the Australian health care system, elements merged / removed
- HLTENN039 Apply principles of wound management in the clinical environment, elements merged / removed.
- HLTENN040 Administer and monitor medicines and intravenous therapy, performance Criteria removed / changed
- □HLTENN058 Apply nursing practice in the perioperative setting, PC added
- HLTENN061 Apply nursing practice in the contemporary aged care setting, PC's added/removed
- HLTENN064 Apply nursing practice in the rural and remote setting, PC's added/removed



## Key questions for considerations

- HLTENN039 Contribute to nursing care of a person with complex needs
- The content of this Unit was merged into
  - HLTENN043 Implement and monitor care for a person with acute health problems and
  - HLTENN044 Implement and monitor care for a person with chronic health problems. Do the revised Units capture the necessary skills to justify the removal of HLTENN039? If not, what needs to be added?
- HLTENN040 Administer and monitor medicines and intravenous therapy
- In terms of the pathophysiology of medication groups, should the wording read
  - pharmacology of medication groups? or
  - pharmacodynamics/therapeutics/kinetics of medication groups?
- Specific mention of sites for medications should be included. However, should this apply to all
  routes/methods rather than just intramuscular or subcutaneous?



## Key questions for considerations

#### HLTENN042 Implement and monitor care for a person with mental health conditions

 PC 4.4 "Confirm that the person understands the use, administration methods and possible effects of medications to be used including known specific adverse effects." in Draft 2 this PC has been removed.

This Unit can be delivered before students have done their medication Unit, or just as they have started their medication Unit. Hence this should be a broader criterion around treatment options and not have such a specific focus on medications, rather than expecting EN students to have such in-depth knowledge of individual medications.

Does this criterion need to be replaced?
