APPLICATION	<p>This unit describes the performance outcomes, skills and knowledge required to work with teachers to support primary and secondary students to develop literacy skills, including oral language, reading and writing skills. It includes the ability to develop literacy resources.</p> <p>The unit applies to education support workers who operate under the guidance and supervision of a teacher or other educational professional. They work mainly with students in classroom settings in primary and secondary schools, as defined by state and territory legislation.</p> <p>The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian standards and industry codes of practice.</p>

Contribute to resource development.	<p>4.1 Plan learning environments and activities in advance with the teacher based on individual needs.</p> <p>4.2 Contribute ideas for resource design that reinforce literacy skills, while fulfilling curriculum requirements and meet developmental levels.</p> <p>4.3 Follow organisational procedures for the production of resources.</p>
